CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 3193

AN ORDINANCE providing for revised water service and consumption charges and sewerage service charges for the Waterworks Utility of the City of Bellevue applicable within the boundaries of the Town of Clyde Hill, amending Ordinance No. 3052 and Ordinance No. 2938.

WHEREAS, the Town of Clyde Hill, by Ordinance No. 460, has decreased the business and occupation tax on the privilege of engaging in certain businesses, including the operation and sale of water and water service, and the operation and sale of services for sewer utilities, within said Town; and

WHEREAS, the Waterworks Utility of the City of Bellevue sells, distributes and furnishes water, and furnishes sanitary sewerage service, within the Town of Clyde Hill, and is subject to said business and occupation tax; and

WHEREAS, it is therefore necessary and in the public interest that water service and consumption charges and sewerage service charges applicable within the boundaries of the Town of Clyde Hill be adjusted downward in an amount to reflect the decrease in said business and occupation tax; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Section 2 of Ordinance No. 3052 is hereby amended to read as follows:

Notwithstanding anything in Ordinance No. 2903 to the contrary, water service and consumption charges payable under Sections 1, 2, 3 and 4 of said Ordinance for locations in the city limits of the Town of Clyde Hill shall be 108.4360% of the appropriate charge for locations outside the city limits of Bellevue as determined under said sections.

Section 2. Section 4 of Ordinance No. 3052 is hereby amended to read as follows:

Notwithstanding anything in Ordinance No. 2177 or Ordinance No. 2369 to the contrary, the sewerage service charges payable under Section 2 of Ordinance No. 2177 and Sections 1 and 3 of Ordinance No. 2369 for locations inside the city limits of the Town of Clyde Hill shall be 108.1967% of the appropriate charges for locations outside the City of Bellevue as determined under said sections.

Section 3. Section 5 of Ordinance No. 3052 is hereby amended to read as follows:

The revised charges herein established shall apply to water and sewer services provided within the Town of Clyde Hill on and after November 1, 1982.


Section 4. Section 3 of Ordinance No. 2938 is hereby amended to read as follows:

The revised charges herein established shall apply to sewerage service provided within the City of Medina and the Town of Yarrow Point on and after February 1, 1981.

Section 5. Posting. This ordinance shall be posted in the three official posting places of the City and shall take effect and be in force five (5) days after the date of posting, providing the rates herein established shall take effect as indicated above and provided further that this ordinance shall remain in effect only until January 1, 1983 on which date it shall expire and have no further force and effect.


