ORDINANCE NO. 3203

AN ORDINANCE authorizing acceptance of a Grant Award Contract with the Urban Arterial Board; creating two new projects within the Urban Arterial Street Fund No. 362; appropriating funds received in excess of estimated revenues within Urban Arterial Street Fund No. 362; and amending Ordinance No. 3065.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or her designated representative is authorized and directed to accept a Grant Award Contract with the Urban Arterial Board for the following programs: Project A-21, Bellevue Way, Main to N.E. 12th and Project A-22, 156th Avenue N.E., Bellevue-Redmond Road to N.E. 8th Avenue.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend same as authorized in said Grant Award Contract.

Section 3. There shall be established projects within Urban Arterial Board Street Fund No. 362 to be known as 1) Project A-21, Bellevue Way, Main Street to N.E. 12th Avenue and 2) Project A-22, 156th Avenue N.E., Bellevue-Redmond Road to N.E. 8th Avenue, in which all of said money shall be deposited.

Section 4. The City Manager or her designated representative shall have responsibility for the administration of said grants.

Section 5. The approximate, anticipated sources of revenue for the grant proposal and acceptance are:

Section 6. Upon execution and acceptance of said Grant Awards, Section 2 of 1982 Budget Ordinance No. 3065 shall be and hereby is amended by appropriating revenue received during the current fiscal year

in excess of estimated revenues as a result of the Grant Award acceptance herein authorized within Urban Arterial Board Street Fund No. 362 in not more than the following amounts.



Provided, however, that if the actual sources of revenue specified in said grant award should be less than the amounts provided herein, the amount appropriated herein shall be adjusted to be equal to said lesser amount.

Section 7. This Ordinance shall be published by posting it in the three official posting places of the City and shall take effect and be in force five days after the date of posting.




