ORDINANCE NO. 3226

AN ORDINANCE relating to the 1983 budget; authorizing acceptance of additional grant awards for the construction of Merrywood School; authorizing deposit of such additional grant award funds into the Referendum 37 - Merrywood School Project of the Grant Control Fund No. 164; appropriating funds received in excess of estimated revenues; and amending Ordinance No. 3212.

WHEREAS, the City Council by Ordinance No. 3050 authorized acceptance of a Referendum 37 grant award from the Department of Social and Health Services of the State of Washington for construction of Merrywood School; and

WHEREAS, the Merrywood School has received additional matching grant funds from the Boeing Company, Safeco Insurance Company and the Bishop Foundation, which are to be used for construction of Merrywood School; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or her designated representative is hereby authorized and directed to accept grant awards received by Merrywood School from the Boeing Company, Safeco Insurance Company, and the Bishop Foundation, in the total amount of \$50,000 for the construction of Merrywood School.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive said monies and to expend the same as authorized in the grant award contract with the Department of Social and Health Services of the State of Washington which was executed pursuant to Ordinance No. 3050.

Section 3. At the time of receipt of said funds, they shall be deposited in the Referendum 37 - Merrywood School Project within the Grant Control Fund No. 164.

Section 4. The City Manager or her designated representative shall have responsibility for the administration of said grants.

Section 5. The approximate, anticipated sources of revenue for the

grant awards accepted herein are as follows:

Boeing Company	\$25,000
Safeco Insurance Company	15,000
Bishop Foundation	<u>10,000</u>
TOTAL	\$50,000

Section 6. Upon acceptance and receipt of said grant awards, Section 2 of the 1983 Budget Ordinance No. 3212 shall be and hereby is amended by appropriating funds received during the current fiscal year in excess of estimated revenues as a result of the grant awards herein authorized to be accepted for the Referendum 37 - Merrywood School Project within Grant Control Fund No. 164, in not more than the following amount:

Grant Control Grant Fund No. 164 - Referendum 37 - Merrywood School Project	\$50,000

Provided, however, if the actual revenue received from the sources specified in Section 5 hereof should be less than \$50,000, the amount appropriated herein shall be adjusted to be equal to said lesser amount.

Section 7. The City Clerk is directed to transmit a certified copy of this ordinance to the Auditor of the State of Washington, Division of

Section 8. This ordinance shall be published by posting it in the three official posting places of the City, and shall take effect and be in force five days after the date of posting.


