CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 3279

AN ORDINANCE relating to the 1983 budget; appropriating funds received in excess of estimated revenues in Urban Arterial Board Street Fund No. 362 to Project A-22, the 156th Avenue N.E., Bellevue-Redmond Road to N.E. 8th Street Project; and amending Ordinance No. 3212.

WHEREAS, the City Council by Ordinance No. 3203 authorized acceptance of a grant award from the Urban Arterial Board for Project A-22, the 156th Avenue N.E., Bellevue-Redmond Road to N.E. 8th Street Project within the Urban Arterial Board Street Fund No. 362; and

WHEREAS, Ordinance No. 3203 and Ordinance No. 3230 appropriated a total of \$263,000 to said Project; and

WHEREAS, expenditures previously authorized for said project, including contract change orders, total approximately \$431,000; and

WHEREAS, the funds necessary to pay the total costs of the project previously were appropriated in several funds; and

WHEREAS, it is desirable to appropriate all authorized funds for the project to Project A-22 in Urban Arterial Street Fund No. 362, in order that all project costs will be paid out of the same project fund; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The approximate, anticipated sources of revenue for the total appropriation set forth below are:

Street Improvement Project Funds - Street Capital Improvement Fund No. 366	\$ 63,000

Section 2. Section 2 of the 1983 Budget Ordinance No. 3212 is amended by appropriating funds received in excess of estimated revenues to the 156th Avenue N.E., Bellevue-Redmond Road to N.E. 8th Street Project A-22 within Urban Arterial Board Street Fund No. 362, in not

more than the following amount:

Provided, however, if the actual revenue received for said Project A-22 from the sources specified hereinabove should be less than \$431,000, the amount appropriated herein shall be adjusted so that the total amount appropriated herein and by Ordinances No. 3203 and 3230 to said Project A-22 is equal to said lesser amount.

Section 3. The City Clerk is directed to transmit a certified copy of this ordinance to the Auditor of the State of Washington, Division of Municipal Corporations.

Section 4. This ordinance shall be published by posting it in the three official posting places of the City, and shall take effect and be in force five days after the date of posting.
