ORDINANCE NO. 3307

AN ORDINANCE amending the budget for certain special purpose non-budgetary Funds by appropriating unanticipated and future revenues to those Funds.

Section 1. The budget for each special purpose non-budgetary Fund set forth below is hereby amended by appropriating to each such Fund unanticipated and future revenues in excess of estimated revenues in the amounts set forth opposite each such Fund:


forth in Appendix A, which by this reference is incorporated herein, and which has been given Clerk's Receiving No. 8812.


