CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 3370

AN ORDINANCE authorizing and directing submittal of a proposal to and acceptance of a grant award contract with the United States Department of Housing and Urban Development; creating a new project within Grant Control Fund No. 164; and amending the budget for Grant Control Fund No. 164 created by Ordinance No. 1987 by appropriating unanticipated and future revenues to that fund.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or her designated representative is hereby authorized and directed to submit a proposal to and to execute a grant award contract with the United States Department of Housing and Urban Development for the following program: Community Development Block Grant.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend same as authorized in said grant award contract.

Section 3. There shall be established at the time of execution and acceptance of said grant award contract, a project series within Grant Control Fund No. 164, to be known as the Community Development Block Grant, in which all of said monies shall be deposited.

Section 4. The City Manager or her designated representative shall have responsibility for the administration of said grant.

Section 5. The approximate amount and anticipated source of revenue for the grant proposal and acceptance is:

Section 6. Upon execution and acceptance of said grant award contract, the budget for Grant Control Fund No. 164 authorized by Ordinance No. 1987, as amended, is hereby amended by appropriating to that fund unanticipated and future revenues in excess of estimated revenue in the amount of the grant proposal and acceptance herein authorized to the Community Development Block Grant program within Grant

Control Fund No. 164, currently anticipated as the following amount:

<u>DESCRIPTION</u>	<u>AMOUNT APPROPRIATED</u>
Grant Control Fund No. 164 - Community Development Block Grant Program	\$500,000

Provided, however, if the actual revenue received from the source specified in said grant award should be more or less than the anticipated amount set forth herein the amount appropriated herein shall be adjusted to be equal to the amount actually received.

Section 7. The City Clerk is directed to transmit a certified copy of this ordinance to the Auditor of the State of Washington, Division of Municipal corporations.

Section 8. This ordinance shall be published by posting it in the three official posting places of the City, and shall take effect and be in force five days after the day of posting.


