CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 3382

AN ORDINANCE authorizing acceptance of a Grant Award Contract with the Urban Arterial Board; creating a new project within Urban Arterial Street Fund No. 362; and appropriating funds received in excess of estimated revenues within Urban Arterial Street Fund No. 362.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or her designated representative is authorized and directed to accept a Grant Award Contract with the Urban Arterial Board for the following project: (C.I.P. Project No. PW-R-18) Main Street from Bellevue Way (104th Avenue N.E.) to 108th Avenue N.E.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend same as authorized in said Grant Award Contract.

Section 3. There shall be established a project within Urban Arterial Fund No. 362 to be known as (C.I.P. Project No. PW-R-18) Main Street from Bellevue Way (104th Avenue N.E.) to 108th Avenue N.E., in which all of said money shall be deposited.

Section 4. The City Manager or her designated representative shall have responsibility for the administration of said Grant Award Contract.

Section 5. The approximate amount and anticipated source of revenue is:

Section 6. Upon execution and acceptance of said Grant Award Contract, the budget for Urban Arterial Street Fund No. 362 shall be and hereby is amended by appropriating revenue received during the current fiscal year in excess of estimated revenues, as a result of the Grant Award Contract herein authorized, to Urban Arterial Street Fund No. 362 in not more than the following amount:

<u>Description</u>	<u>Amount Appropriated</u>
Main Street from Bellevue Way to 108th Avenue N.E. (C.I.P. Project No. PW-R-18)	\$49,590

Provided, however, that if the actual amount of revenue specified in said Grant Award Contract should be less than the amount provided herein, the amount appropriated herein shall be adjusted to be equal to said lesser amount.

Section 7. This ordinance shall be published in the three official posting places of the City, and shall take effect and be in force five days after the day of posting.


