CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 3572

AN ORDINANCE providing for revised water service and consumption charges for the Waterworks Utility of the City of Bellevue; and repealing Ordinance Nos. 3317, 3344, 3345, 3349 and 3450.

WHEREAS, it is necessary and in the public interest to provide for the following schedule of revised rates for water service and water consumption for the Waterworks Utility of the City of Bellevue and to comply with federal law and regulations; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Charges established - effective date. There are hereby established and shall be collected from each user of water service provided by the Waterworks Utility of the City of Bellevue water service and water consumption charges as hereinafter provided. The charges hereby established shall apply to water service provided on and after January 1, 1986 and shall supercede all existing schedules of charges as of said date. Ordinance Nos. 3317, 3344, 3345, 3349, and 3450 are repealed.

Section 2. The service charge per bimonthly billing period for each user of water service, except those specifically governed by Sections 4 and 5 herein, for locations outside the city or town limits of Bellevue, Clyde Hill, Hunts Point, Medina and Yarrow Point shall be as follows:

The charge for locations inside the city or town limits of the following cities and towns shall be determined by multiplying that appropriate charge above by the percentage indicated below for that city or town.

Section 3. The consumption charge for bimonthly billing period for each user of water service, except those specifically governed by Sections 4 and 5 herein, for locations outside the city or town limits of Bellevue, Clyde Hill, Hunts Point, Medina, and Yarrow Point, shall be as follows:

<u>Cubic Feet Consumed</u>	<u>Charge per 100 Cubic Feet of Water</u>
0 - 800	No charge
Over 800	\$0.85

The charge for locations inside the city or town limits of the following cities and towns shall be determined by multiplying the appropriate charge above by the percentage indicated below for that city or town.

Section 4. The charge per bimonthly billing period for each multi-family residential structure or facility served through a single meter, for locations outside the city or town limits of Bellevue, Clyde Hill, Hunts Point, Medina, and Yarrow Point shall be as follows:

B. A service charge of \$11.07 per dwelling unit, excepting one dwelling unit; plus,

C. A consumption charge for all water consumed in excess of 700 cubic feet per dwelling unit based on the following table.

<u>Cubic Feet Consumed Per Dwelling</u>	<u>Charge Per 100 Cubic Feet of Water</u>
1 - 700	None
Over 700	\$0.85

Section 5. The charge for bimonthly billing period for each multi-family residential structure or facility served through a single meter for locations inside the city or town limits of Bellevue, Clyde Hill, Hunts Point, Medina, and Yarrow Point shall be determined by multiplying the appropriate charge for service and consumption of water as set forth in Section 4 above by the percentage indicated below for that city or town.

Section 6. For purposes of Sections 4 and 5 herein, "multi-family residential structure or facility" shall mean any residential structure or facility containing two or more dwelling units, including, but not limited to, duplexes, triplexes, apartment buildings, trailer parks, and parcels containing two or more separate dwelling units, but shall not include hotels and motels.

Section 7. The service charge per bimonthly billing period for fire standby meters for locations outside the city or town limits of Bellevue, Clyde Hill, Hunts Point, Medina, and Yarrow Point shall be as follows:

For locations inside the city or town limits of the following cities and towns the change shall be determined by multiplying the appropriate charge above by the percentage indicated below for that city or town.

<u>City or Town</u>	<u>Percentage</u>
Bellevue	105.3232
Clyde Hill	107.7734
Hunts Point	107.3470
Medina	104.9740
Yarrow Point	103.2619

Section 8. If any section of this ordinance or any portion of any section of this ordinance, or its application to any person or circumstances is held invalid, the remainder of the Ordinance or the application of the provision to other persons and circumstances, shall not be affected.

Section 9. This ordinance shall take effect and be in force five (5) days after its passage and legal publication.


