CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 3624

AN ORDINANCE reclassifying 8.1 acres of property (Site 14) in the North Bellevue Subarea developed as a portion of the Everwood Office Park and located east of 112th Avenue N.E. between N.E. 19th and N.E. 24th Streets.

WHEREAS, an application for reclassification of the property hereinafter described was duly filed with the appropriate City officials;

WHEREAS, on January 17, 1985, a public hearing was held thereon before the Hearing Examiner upon proper notice to all interested persons; and

WHEREAS, on February 24, 1986, the Hearing Examiner recommended to the City Council approval of said reclassification of said property located east of 112th Avenue N.E. between N.E. 19th and N.E. 24th Streets in the North Bellevue Subarea from R-20 to O; and made and entered findings of fact and conclusions based thereon in support of his recommendation; and

WHEREAS, the City Council concurs in the findings of fact and conclusions of the Hearing Examiner and has determined that the public use and interest will be served by reclassifying said property; and

WHEREAS, the City has complied with the requirements of the State Environmental Policy Act and the City Environmental Procedures Ordinance; now, therefore

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Council adopts the findings of fact and conclusions based thereon made and entered by the Hearing Examiner in support of his recommendation to the Council in this matter as set forth in "Findings and Recommendation of the Hearing Examiner for the City of Bellevue, In the Matter of the Application of the City of Bellevue For a Reclassification of Property Identified as Site 14 to Implement the North Bellevue Subarea Element of Bellevue's Comprehensive Plan, File No. HE-A 84-2."

Section 2. The use classification of the following described property is changed from R-20 to O:

The West 215 feet of the East half of the Northeast quarter of Section 29, Township 25 North, Range 5 East, W.M., in King County, Washington lying Northerly of the North line of Lot 1 and Lot 2 of Bellevue Short Plat 79-20 recorded under Auditor's File Number 7905221049, records of King County, Washington and the Westerly extension of said North line to the West line of said subdivision.

Section 3. This ordinance shall take effect and be in force five days after its passage and legal publication.


