ORDINANCE NO. 3845

AN ORDINANCE authorizing acceptance of grant monies from the State Interagency Committee for Outdoor Recreation and expenditure of said funds for the Newcastle Beach Park Development and Access Project, C.I.P. Project No. P-AD-7.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or his designated representative is authorized and directed to accept grant monies from the State Interagency Committee for Outdoor Recreation for the Newcastle Beach Park Development and Access Project, C.I.P. Project No. P-AD-7.

Section 2. The City Manager or his designated representative is authorized to receive monies and to expand same as authorized in the grant award contract.

Section 3. The City Manager or his designated representative shall have responsibility for the administration of said grant funds.

Section 4. The approximate amount and anticipated source of revenue for Project No. P-AD-7 is:

Section 5. Upon execution and acceptance of said grant award contract, the budget for Grant Control Fund No. 164 shall be and hereby is amended by appropriating revenue received during the current fiscal year in excess of estimated revenues, as a result of the grant funds herein authorized, to Grant Control Fund No. 164 in not more than the following amount.

Provided, however, that if the actual amount of revenue received from the Interagency Committee for Outdoor Recreation should be less than the amount provided herein, the amount appropriated herein shall be adjusted to be equal to said lesser amount. A project is established within Grant Control Fund No. 164, to be designated "Newcastle Beach Park Development and Access Project."

Section 6. This ordinance shall take effect and be in force five days after its passage and legal publication.
