CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 3847

AN ORDINANCE regarding purchasing; amending the bid limits for public works contracts and the purchase of materials, supplies and equipment; amending Bellevue City Code 4.28.040.A. and 4.28.140; and repealing Bellevue City Code 4.28.125.

WHEREAS, by Chapter 120, Laws of Washington, 1987, the state legislature has amended the bid limits applicable to public works projects of cities; and

WHEREAS, the City Council desires to amend the Bellevue City Code to conform to the amendments to state law; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Bellevue City Code 4.28.040.A is hereby amended to read as follows:

4.28.040 Competitive Bidding - Materials, Supplies and Equipment

- A. General. Any purchase of materials, supplies, and equipment where the cost thereof exceeds thirty-five thousand dollars shall be by competitive bidding, except for purchases made pursuant to Sections 4.28.030, 4.28.085 and 4.28.090 of this chapter.

Section 2. Bellevue City Code 4.28.125 is hereby repealed.

Section 3. Bellevue City Code 4.28.140 is hereby amended to read as follows:

4.28.140 When Bids Required for Public Works and Improvements.

Except as otherwise authorized by RCW chapters 39.04 and 39.28, or RCW 35.22.620, relating to emergency public works, or other applicable general state law, as now enacted or as hereafter amended, all public works and improvements shall be done by contract pursuant to public notice and call for competitive bids in accordance with Section 4.28.040 hereof whenever the estimated cost of such public work or improvement, including the cost of materials, supplies, equipment and labor will exceed the sum of thirty-five thousand dollars if more than one craft or trade is involved with the public works project, or in excess of twenty thousand dollars if only a single craft or trade is involved with

the public works project or the public works project is street signalization or street lighting; provided, the city may use a small works roster pursuant to RCW 35.22.620.

Whenever the estimated cost of the public work or improvement is less than the amounts provided above a contract for the public work or improvement shall be awarded in the manner authorized by Sections 4.28.050, 4.28.060 and 4.28.070 for the purchases of materials, supplies and equipment or, within the limits and to the extent authorized by RCW 35.22.620(2), the public work or improvement shall be performed by city employees.

Section 4. This ordinance shall take effect and be in force thirty days after its passage by the City Council.


