ORDINANCE NO. 4067

AN ORDINANCE relating to the establishment of a Residential Permit Parking Zone, with restrictions of one-hour parking 7:00 a.m. to 8:00 p.m., except Saturday, Sunday and holidays, except by permit, on both sides of S.E. 3rd Place west of 140th Avenue S.E.

WHEREAS, residents along S.E. 3rd Place have sent a petition to the City regarding parking spillover in their neighborhood by students from Sammamish High School resulting in vehicles parking for extended periods of time, creating an inconvenience to them and safety concerns; and

WHEREAS, City policy is that on-street parking in residential areas should be limited to the use of residents and their visitors; now, therefore

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Parking of vehicles on both sides of the street listed below shall be restricted to one-hour parking from 7:00 a.m. to 8:00 p.m., except Saturday, Sunday and holidays, except by permit issued pursuant to Section 3 of this ordinance:

S.E. 3rd Place west of 140th Avenue S.E. to and including the cul-de-sac

Section 2. The parking restrictions established by Section 1 of this ordinance shall not apply to any vehicle parking on the street enumerated in Section 1 above when said vehicle has a Zone 6 permit sticker or decal issued pursuant to Section 3 herein, attached or affixed on or otherwise directly visible from the front or rear window of said vehicle.

Section 3. Zone 6 permits may be issued by the Department of Public Works to any resident residing on the street enumerated in Section 1 herein for each vehicle owned by said resident. Visitor permits will be issued to said residents, with said visitor permits being transferable from one vehicle to another. Said visitor permits may also be borrowed and lent between residents. All Zone 6 permits shall be issued pursuant to procedure established by the Department of Public Works which requires proof of residency and vehicle registration prior to issuance.

Section 4. The parking restrictions established by this ordinance shall be filed with and maintained by the City Clerk in accordance with Section 11.23.010 of the Bellevue City Code.

Section 5. This ordinance shall take effect thirty days after final passage.




