CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 4077

AN ORDINANCE authorizing and directing execution of an Interlocal Agreement with King County for a Flood Control Assistance Account Program grant to assist in financing a portion of the Kelsey Creek Channel Improvement Project; establishing a project within Grant Control Fund 164; appropriating funds received in excess of estimated revenues within Grant Fund No. 164; and authorizing expenditure thereof.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or his designee is authorized and directed to execute that certain Interlocal Agreement with King County for the purpose of obtaining a grant to finance a portion of the Kelsey Creek Channel Improvement Project, a copy of which Interlocal Agreement is hereby given Clerk's Receiving No. 14912

Section 2. At the time of execution of said Interlocal Agreement and acceptance of said funds, a project shall be established within Grant Control Fund No. 164 to be known as Kelsey Creek Channel Improvement Project into which all said monies shall be deposited.

Section 3. Upon execution of said Interlocal Agreement and acceptance of said funding, the budget for Grant Control Fund No. 164 shall hereby be amended by appropriating revenues received during the current fiscal year in excess of estimated revenues, as a result of the funding herein authorized, to Grant Control Fund No. 164 in the following amount:

<u>Description</u>	<u>Amount Appropriated</u>
Flood Control Assistance Account Program Grant (Kelsey Creek Channel Improvement Project)	\$53,948

Provided, however, that if the actual revenue received from the source specified in said application should be more or less than the amount set forth herein, the amount appropriated shall be adjusted to be equal to the amount actually received.

Section 4. The amount and anticipated source of revenue for said Kelsey Creek Channel Improvement Project is as follows:

Section 5. The City Clerk is directed to transmit a certified copy of this ordinance to the Auditor of the State of Washington, Division of Municipal Corporations.

Section 6. This ordinance shall take effect and be in force five days after its passage and legal publication.
