## CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 4083

AN ORDINANCE authorizing and directing submittal of a proposal to and acceptance of a grant award contract with the United States Department of Housing and Urban Development; creating a new project series within Grant Control Fund No. 164; amending the budget for Grant Control Fund No. 164 created by Ordinance No. 2475 by appropriating unanticipated and future revenues to that fund; and authorizing the City Manager to enter into contracts with local human services agencies.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or his designated representative is hereby authorized and directed to submit a proposal to and to execute a grant award contract with the United States Department of Housing and Urban Development for the Community Development Block Grant Program.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend same as authorized in said grant award contract, including contracting with local human services agencies to provide community services.

Section 3. There shall be established at the time of execution and acceptance of said grant award contract, a project series within Grant Control Fund No. 164, to be known as the Community Development Block Grant, in which all of said monies shall be deposited.

Section 4. The City Manager or his designated representative shall have responsibility for the administration of said grant monies and shall have all authority necessary to enter into agreements with local human services agencies for the provision of community services in the amounts authorized by the City Council pursuant to its 1990 Human Service Funding plan allocation for such local human services agencies.

Section 5. The approximate amount and anticipated source of revenue for the grant proposal and acceptance is:

Section 6. Upon execution and acceptance of said grant award contract, the budget for Grant Control Fund No. 164 authorized by Ordinance No. 2475, as amended, is hereby amended by appropriating to that

fund anticipated revenues in excess of estimated revenue in the amount of the grant proposal and acceptance herein authorized to the Community Development Block Grant program within Grant Control Fund No. 164, currently anticipated in the following amount:


Provided however, if the actual revenue received from the source specified in said grant award should be more or less than the anticipated amount set forth herein, the appropriation shall be adjusted to be equal to the amount actually received.

Section 7. The City Clerk is directed to transmit a certified copy of this ordinance to the Auditor of the State of Washington, Division of Municipal Corporations.

Section 8. This ordinance shall take effect and be in force five days after its passage and legal publication.


