CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 4196

AN ORDINANCE providing for revised water service and water consumption charges for the Waterworks Utility of the City of Bellevue applicable within the boundaries of the City of Bellevue and the Town of Medina; and amending Ordinance No. 4151.

WHEREAS, the City of Bellevue, by Ordinance No. 4194, reduced its utility tax on the privilege of engaging in certain businesses, including the provision of water and water service within said City; and

WHEREAS, the Town of Medina, by Ordinance No. 526, reduced its public utility tax on the privilege of engaging in certain businesses, including the provision of water and water service in said Town; and

WHEREAS, the Waterworks Utility of the City of Bellevue sells, distributes and furnishes water within the City of Bellevue and within the Town of Medina and is subject to said respective utility taxes; and

WHEREAS, it is therefore necessary and in the public interest that water service and consumption charges applicable within the boundaries of the City of Bellevue and within the boundaries of the Town of Medina be adjusted in an amount to reflect such modifications in said respective utility taxes; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Section 5 of Ordinance No. 4151 is hereby amended to read as follows:

Section 5. The charges for each user inside the city or town limits of Bellevue, Clyde Hill, Hunts Point, Medina and Yarrow Point shall be determined by multiplying the Section 4 charges by the percentage indicated below for that city or town:

Section 2. Section 6 of Ordinance No. 4151 is hereby amended to read as follows:

Section 6. The service charge per bimonthly billing period for fire standby meters for locations outside the city or town limits of Bellevue, Clyde Hill, Hunts Point, Medina, and Yarrow Point shall be as follows:

2"	\$ 8.91
3"	11.46
4"	14.00
6"	21.64
8"	34.36
10"	47.08
12"	63.61

For locations inside the city or town limits of the following cities and towns, the charge shall be determined by multiplying the appropriate charge above by the percentage indicated below for that city or town:



Section 3. This ordinance shall take effect and be in force on January 1, 1991; provided, however, that the new multiplier for the City of Medina shall not be effective until March 31, 1991. The changes hereby established shall supersede any conflicting, existing changes established by prior ordinances.
