## CITY OF BELLEVUE, WASHINGTON

### ORDINANCE NO. 4382

AN ORDINANCE relating to speed limits; establishing the speed limit at 35 miles per hour on Lakemont Boulevard S.E. from 164th Avenue S.E. to the east city limits, and Village Park Drive S.E. from Lakemont Boulevard S.E. to 179th Avenue S.E.; and amending Section 3 of Ordinance No. 4239 and Section 11.32.022 of the Bellevue City Code.

WHEREAS, the City has annexed an area near the intersection of Lakemont Boulevard S.E. and Village Park Drive S.E.; and

WHEREAS, those streets were designed for a speed of thirty-five miles per hour; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Section 3 of Ordinance No. 4239 and Section 11.32.022 of the Bellevue City Code are amended to read as follows:

#### 11.32.022 Speed limits established—Thirty-five miles per hour.

The speed limit on the following streets is thirty-five miles per hour:

Bellevue-Redmond Road from 124th Avenue NE to 156th Avenue NE;  
Bellevue Way NE from NE 12th Street to north city limits;  
Henry Richards Road from Interstate No. 90 to Lake Hills Connector;  
Kamber Road from 145th Place SE to Henry Richards Road;  
Lake Hills Connector from SE 5th Street to SE 8th Street;  
Lakemont Boulevard S.E. from 164th Avenue S.E. to the east city limits;  
Northup Way from Bellevue Way NE to 132nd Avenue NE;  
Northup Way from West Lake Sammamish Parkway NE to Bellevue-Redmond Road;  
Village Park Drive S.E. From Lakemont Boulevard S.E. to 179th Avenue S.E.  
West Lake Sammamish Parkway SE and NE (SR 901) from the south city limits to the north city limits;  
NE 8th Street from 124th Avenue NE to 156th Avenue NE;  
NE 20th Street from 132nd Avenue NE to 148th Avenue NE;  
NE 24th from 140th Avenue NE to 148th Avenue NE;  
NE 40th from 140th Avenue NE to 148th Avenue NE;  
SE Eastgate Way from 128th Avenue SE to 148th Avenue SE;  
SE 36th Street from 150th Avenue SE to west city limits;  
112th Avenue SE from Bellevue Way SE to Main Street;  
112th Avenue NE from NE 24th to NE 31st Street;

132nd Avenue NE from NE 40th Street to north city limits;

148th Avenue NE and SE from SE 28th Street to NE 24th Street.


