CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 4532

AN ORDINANCE authorizing execution of a Public Works Trust Fund Loan Agreement with the State of Washington Department of Community Development for engineering services and construction of the Coal Creek Parkway Sedimentation Facility in the City; amending the budget for the Public Works Trust Fund by appropriating monies received; and authorizing expenditure of said monies.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or his designated representative is hereby authorized to execute on behalf of the City that certain Public Works Trust Fund Loan Agreement No. PW-5-93-280-005 between the City of Bellevue and the State of Washington Department of Community Development for the Coal Creek Parkway Sedimentation Facility Project, a copy of which Agreement has been given Clerk's Receiving No. 19132.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend the same as authorized in said Agreement.

Section 3. There shall be established at the time of execution and acceptance of said Public Works Trust Fund Loan Agreement a project within the Waterworks Construction Fund, into which all said monies shall be deposited.

Section 4. Upon execution and acceptance of said Agreement, the budget for the Waterworks Construction Fund shall be amended by appropriating to that fund unanticipated revenues in excess of estimated revenue in the amount of the loan agreement and acceptance herein authorized to said fund, currently estimated in the following amount.

Provided, however, if the actual revenue received should be more or less than the estimated amount set forth herein, the appropriation shall be adjusted to equal the amount actually received.

Section 6. The City Clerk is directed to transmit a certified copy of this ordinance to the Auditor of the State of Washington, Division of Municipal Corporations.

Section 7. This ordinance shall take effect and be in force five (5) days after its passage and legal publication.


