CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 4566

AN ORDINANCE regarding parks, recreation and community services facilities; amending Section 1 (part) of Ordinance No. 4488 and Bellevue City Code Section 3.43.020.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Section 1 (part) of Ordinance No. 4480, and Bellevue City Code Section 3.43.020 are hereby amended to read as follows:

3.43.020 Definitions.

Unless clearly inconsistent with the context in which used, the following definitions shall apply under this chapter:

1. "Director" means the director of the Department of Parks and Community Services and authorized agents of the director.

2. "Park" means all parks and bodies of water contained therein, squares, plazas, trails, golf courses, museums, beaches, playgrounds, playfields, botanical gardens, greenbelts and other park, recreation and open space areas, buildings and facilities comprising the parks and recreation system of the City under the management and control of the City Manager or his or her designee.

3. "Recreation program" means any program or activity conducted, sponsored or assisted by the Department, whether or not it occurs in a park.

4. "Department" means the Department of Parks and Community Services of the City of Bellevue.

5. "Non-motorized watercraft" means those floating devices which are designed to support or help support a person or persons in water and which may or may not be propelled by the use of oars, paddles or sails.

6. "Inflatable, non-motorized watercraft" means those non-motorized watercraft which have two or more inflatable chambers and are propelled by two or more oars.

7. "Motorized watercraft" means those floating devices which are designed to be propelled by the use of internal combustion engines or electric motors. Inflatable, motorized watercraft may be

included in this definition if they are propelled by the use of internal combustion engines or electric motors.

8. "Non-motorized cycle or similar device" means any wheeled, operator-propelled equipment which transports the operator on land, except wheelchairs. Non-motorized cycle or similar device includes, but is not limited to, unicycles, skateboards, bicycles, tricycles, quadcycles and scooters.

9. "Swimming season" means the period of time, as designated by the City Manager or his or her designee, from approximately mid-June to the first week in September, when lifeguards are on daily duty at park swimming beaches.

10. "Non-swimming season" means that portion of the year which has not been designated as the swimming season.

Section 2. This ordinance shall take effect and be in force five (5) days after its passage and legal publication.
