ORDINANCE NO. 4665

AN ORDINANCE extending the boundaries of the existing Surrey Downs Neighborhood Residential Parking Zone (RPZ) to S.E. 4th Street, with restrictions of two-hour parking, except by permit, and amending Ordinance No. 3581 as amended by Ordinance No. 3881.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Section 1. of Ordinance 3581 as amended by Ordinance No. 3881 is hereby further amended to read as follows:

Section 1. Parking of vehicles on both sides of the streets listed below shall be restricted to two-hour parking from 8 a.m. to 6 p.m. except Saturday, Sunday, and holidays, except by permit issued pursuant to Section 3 of this ordinance:

110th Avenue S.E. from Main Street to S.E. 4th Street  
109th Avenue S.E. from S.E. 1st Street to S.E. 3rd Street  
110th Place S.E. from S.E. 2nd Street to S.E. 3rd Street  
111th Avenue S.E. from S.E. 1st Street to S.E. 3rd Street  
S.E. 2nd Street from 108th Avenue S.E. to 109th Avenue S.E.  
S.E. 2nd Street from 110th Street S.E. to 111th Street S.E.  
S.E. 1st Street from 109th Street S.E. to 110th Street S.E.  
S.E. 1st Street from 111th Street S.E. to 112th Street S.E.  
S.E. 3rd Street from 109th Street S.E. to 110th Street S.E.  
109th Avenue S.E. from S.E. 3rd Street to 113 feet south of  
S.E. 4th Street  
110th Place S.E. from the 300 Block to 114 feet south of  
S.E. 4th Street  
111th Avenue S.E. from the 300 Block to 154 feet south of  
S.E. 4th Street  
S.E. 4th Street from 109th Avenue S.E. to 20 feet west of  
112th Avenue S.E.

Section 2. The parking restrictions established by this ordinance shall be filed with and maintained by the City clerk in accordance with Section 11.23.010 of the Bellevue City Code.
