CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 4927

AN ORDINANCE establishing parking restrictions in the Downtown area of the City and in certain other areas of the City; amending Bellevue City Code 11.23.030; and repealing Sections 2 through 6 of Ordinance No. 702; Sections 6, 8 through 11 and 14 through 17 of Ordinance No. 2538; and Ordinance Nos. 931, 1026, 2219, 2656, 2856, 3243, 3296, 3411, 3430, 3434, 3789, 3819, 3826, 3895, 3916, 3924, 3925, 4116, 4538, 4558, 4674, 4687 and 4772.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Except for the streets, or portions of streets, listed in Sections 2 through 5 of this ordinance, as they may hereafter be amended, there is "No Parking Anytime" on both sides of all streets in the area of the City (known as the Downtown Land Use District) that is bounded on the north by the north right of way line of N.E. 12th Street; on the east by the west right of way line of Interstate 405; on the south by the south right of way line of Main Street; and on the west by the west right of way line of 100th Avenue N.E.

Section 2. Parking of vehicles on the following streets, or portions of streets, is restricted to "Two Hour Parking From 7 a.m. To 6 p.m., Except Sundays And Holidays:"

- A. The east side of 103rd Avenue NE from NE 10th Street to the Post Office entrance;
- B. The south side of NE 1st Street between 100th Avenue NE and 102nd Avenue NE;
- C. The north side of NE 1st Street between 102nd Avenue NE and Bellevue Way NE;
- D. The east side of 102nd Avenue NE between Main Street and NE 1st Street;
- E. Both sides of 103rd Avenue NE between Main Street and NE 1st Street;
- F. Both sides of Main Street between 100th Avenue NE and 103rd Avenue NE;

- G. The east side of 106th Place NE from NE 12th Street to the south end of the road;
- H. The east side of 105th Avenue NE between NE 2nd Street and NE 4th Street;
- I. Both sides of 106th Avenue NE between NE 10th Street and NE 12th Street;
- J. The east side of 106th Avenue NE between NE 4th Street and NE 6th Street;
- K. The west side of 106th Avenue NE between Main Street and NE 2nd Street;
- L. The west side of 110th Avenue NE between NE 12th Street and NE 10th Street;
- M. The west side of 110th Place NE between NE 10th Street and NE 11th Street;
- N. Both sides of NE 3rd Place from 111th Avenue NE to the west end of the road;
- O. Both sides of NE 2nd Place between 108th Avenue NE and 111th Avenue NE;
- P. The west side of 111th Avenue NE between NE 2nd Place and NE 4th Street;
- Q. Both sides of NE 2nd Street between 108th Avenue NE and 110th Avenue NE;
- R. Both sides of 110th Avenue NE between Main Street and NE 2nd Street;
- S. The west side of 107th Avenue NE from NE 2nd Street to 100 feet south of the south edge of N.E. 2nd Street.

Section 3. Parking of vehicles on the following streets, or portions of streets, is restricted to "No Parking From 7 a.m. To 6 p.m., Except Sundays And Holidays:"

- A. Both sides of NE 2nd Street between 105th Avenue NE and 108th Avenue NE;

- B. Both sides of NE 2nd Street between 110th Avenue NE and 112th Avenue NE;
- C. The west side of 106th Avenue NE from NE 6th Street to the NE 500 Block;
- D. The east side of 108th Avenue NE between NE 4th Street and NE 6th Street;
- E. Both sides of 108th Avenue NE between NE 6th Street and NE 8th Street;
- F. Both sides of 108th Avenue NE between NE 10th Street and NE 12th Street;
- G. Both sides of 109th Avenue NE between NE 9th Street and NE 10th Street;
- H. The east side of 110th Place NE between NE 10th Street and NE 11th Street;
- I. Both sides of 111th Avenue NE between NE 10th Street and NE 11th Street;
- J. Both sides of 111th Avenue NE between 110th Avenue NE and 112th Avenue NE;

Section 4. Parking of vehicles on both sides of 100th Avenue NE between NE 1st Street and NE 4th Street is restricted to "No Parking From 7:00 a.m. to 6:00 p.m., Except Saturdays, Sundays and Holidays."

Section 5. Parking of vehicles on the east side of 114th Avenue N.E. from 200 feet south of N.E. 4th Street to N.E. 6th Street is restricted to "No Parking Anytime Except Metro Transit Vehicles."

Section 6. Parking of vehicles on the specified portions of the following streets is restricted as follows:

- A. Parking on the east side of 105th Avenue S.E. from Main Street to 140 feet south of the south right of way line of Main Street is restricted to "Two Hour Parking From 7:00 a.m. To 6:00 p.m., Except Sundays And Holidays;"
- B. There is "No Parking Anytime" on the following portions of the following streets:

1. Both sides of 116th Avenue N.E. between N.E. 12th Street and N.E. 24th Street;
2. Both sides of N.E. 8th Street between the west right of way line of Interstate 405 and West Lake Sammamish Parkway;
3. Both sides of Main Street between the west right of way line of Interstate 405 and 116th Avenue, and between 140th Avenue and 156th Avenue, provided that this restriction does not apply to the south side of Main Street within a 315 foot section of roadway located between 165 feet and 480 feet west of 148th Avenue, and provided, further, that this restriction does not apply to the north side of Main Street from 145th Place N.E. to 140 feet west of the west edge of 145th Place N.E.;
4. Both sides of 112th Avenue between Bellevue Way S.E. and Main Street and between N.E. 12th Street and N.E. 24th Street;
5. Both sides of Bellevue Way between the north city limits and N.E. 12th Street and between Main Street and S.E. 30th Street;
6. Both sides of N.E. 10th Place between the Bellevue-Redmond Road and 124th Avenue N.E.;
7. Both sides of N.E. 12th Street between the west right of way line of Interstate 405 and 124th Avenue N.E.;
8. Both sides of 120th Avenue N.E. between the Bellevue-Redmond Road and N.E. 12th Street;
9. Both sides of 148th Avenue between S.E. Eastgate Way and the north city limits;
10. Both sides of 118th Avenue S.E. between S.E. 8th Street and the south city limits;
11. Both sides of 114th Avenue S.E. between Main Street and S.E. 8th Street;
12. Both sides of 100th Avenue N.E. between N.E. 12th Street and N.E. 13th Street;
13. Both sides of 124th Avenue N.E. between N.E. 8th Street and Northup Way;

14. Both sides of the Bellevue-Redmond Road between N.E. 8th Street and N.E. 10th Place and between 124th Avenue N.E. and the north city limits;
15. The north side of S.E. 16th Street between 145th Place S.E. and 156th Avenue S.E.;
16. The east side of 164th Avenue N.E. between N.E. 21st Place and N.E. 24th Street;
17. The east side of 108th Avenue S.E. between Bellevue Way S.E. and S.E. 34th Street and the west side of 108th Avenue S.E. between S.E. 3rd Street and S.E. 10th Street.

C. There is "No Parking, Stopping or Standing Anytime" on both sides of Somerset Boulevard S.E. from S.E. Newport Way to 270 feet west of S.E. 42nd Street.

Section 7. Bellevue City Code 11.23.030 is amended to read as follows:

Any vehicle parked or used so as to endanger any user or potential user of any street or way open to the public or parked or used in violation of Title 11 of the Bellevue City Code, any regulation or restriction established thereunder, or any other applicable provision of the Bellevue City Code or of any ordinance, is declared to be a nuisance which may be summarily abated by the impounding and removal of the vehicle as herein provided. Any vehicle which is stolen, or which is required by the police department for evidence or investigation, or which is unoccupied or unattended and in the judgment of any police officer in danger of being stripped or stolen, or any wrecked and unattended vehicle, may be impounded and removed as provided by state law.

Section 8. Sections 2 through 6 of Ordinance No. 702; Sections 6, 8 through 11 and 14 through 17 of Ordinance No. 2538; and Ordinance Nos. 931, 1026, 2219, 2656, 2856, 3243, 3296, 3411, 3430, 3434, 3789, 3819, 3826, 3895, 3916, 3924, 3925, 4116, 4538, 4558, 4674, 4687 and 4772 are repealed.

Section 9. The parking restrictions established by this ordinance shall be filed with and maintained by the City Clerk in accordance with Section 11.23.010 of the Bellevue City Code.


