ORDINANCE NO. 4954

AN ORDINANCE fixing the amount of property taxes to be levied for the year 1997.

WHEREAS, RCW 35A.33.135 requires the City Manager, by the first Monday in October of each year, to provide the City Council with current information on estimates of revenues and expenditures for the current year; and

WHEREAS, said statute requires the Council to consider the City's total anticipated financial requirements for the ensuing fiscal year and to determine and fix by ordinance the amount to be raised by ad valorem property taxes; and to certify the same to the Clerk of the King County Council on or before December 6, 1996; and

WHEREAS, said date for certification has this year been extended by King County to December 10, 1996; and

WHEREAS, the assessed valuation of all taxable property within the City as determined by the King County Assessor is \$11,308,205,117; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. There is hereby appropriated, levied and fixed to be raised by regular ad valorem property taxes for 1997 the amount of \$21,026,183 which is \$5,627,432 less than the maximum regular property tax levy permitted and authorized by law for this City.

Section 2. There is hereby levied for 1997 upon all property, both real and personal, within the City of Bellevue, Washington, and within the area subject to tax levies for the principal and interest of all general obligation bond issues, a total voted property tax of \$3,852,000 to be apportioned as shown below, on each and every dollar of assessed valuation for such property.

Section 3. The City Clerk is directed to transmit a certified copy of this ordinance to the Office of the Auditor of the State of Washington, Division of Municipal Corporations. The Clerk is further directed to transmit a certified copy of this ordinance to the Council Administrator-Clerk of the King County Council and to the King County Assessor on or before December 10, 1996.



PASSED by the City Council this 9th day of December, 1996, and signed in authentication of its passage this 9th day of December, 1996.




