

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 5772

AN ORDINANCE establishing parking restrictions to implement the parking of authorized transit vehicles on the east side of 124th Avenue SE, starting approximately 350 feet north of the SE 44th Street intersection and extending northward a distance of 100 feet; amending Section 2 of Ordinance 5306 as last amended by Ordinance No. 5320; and amending Section 1 of Ordinance No. 5382 adopted July 15, 2002.

WHEREAS, the City Council adopted Resolution No. 6393 on February 22, 2000, authorizing the use of on-street space in the City for layover zones for authorized transit vehicles; and

WHEREAS, Resolution No. 6393 provided that the Council would at a later date adopt the necessary on-street parking restrictions to implement the Resolution; and,

WHEREAS, the City Council adopted Ordinance Nos. 5306 and 5320 adopting on-street parking restrictions to implement Resolution No. 6393; and,

WHEREAS, on July 15, 2002, the City Council adopted Ordinance No. 5382 creating a "No Parking 7 a.m. – 3 p.m. Monday – Friday" zone on 124th Avenue SE; and,

WHEREAS, a portion of the no parking zone created by Ordinance No. 5382 will be converted to a transit layover zone; now, therefore;

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Section 2 of Ordinance 5306 as last amended by Ordinance No. 5320, adopted September 24, 2001, is amended as follows:

Section 2. The Transportation Department may post signs permitting parking of authorized transit vehicles in such areas of the following described street sections as it determines appropriate. Such authorized transit vehicles may park in such posted areas without regard to any parking restrictions which otherwise would apply to them. No vehicle other than such an authorized transit vehicle may park in such posted areas:

- A. The west side of 110th Avenue between NE 10th Street and NE 12th Street.
- B. The south side of NE 6th Street between 110th Avenue NE and 112th Avenue NE.
- C. The east side of 105th Avenue NE between NE 2nd Street and NE 4th Street.

- D. Both sides of 108th Avenue NE between NE 6th Street and NE 8th Street.
- E. The south side of NE 10th Street between 100th Avenue NE and 102nd Avenue NE.
- F. The east side of 108th Avenue between NE 4th Street and NE 6th Street.
- G. The east side of 116th Avenue between Main Street and NE 4th Street.
- H. The east side of 114th Avenue NE from SE 6th Street to NE 6th Street.
- I. The east side of 100th Avenue NE between Main Street and NE 1st Street.
- J. The east side of 124th Avenue SE, starting approximately 350 feet north of the SE 44th Street intersection and extending northward a distance of 100 feet.


Section 2. Section 1 of Ordinance No. 5382 adopted July 15, 2002, is hereby amended as follows:

The parking of vehicles on the east side of 124th Avenue SE, starting 100 feet north of the SE 44th Street intersection and extending northward a distance of 250 feet is restricted to "No Parking 7a.m. - 3.p.m. Monday - Friday".

Section 3. This ordinance shall take effect and be in force thirty (30) days after passage and legal publication.
