ORDINANCE NO. 5809

AN ORDINANCE authorizing execution of the 2008-2009 Waste Reduction and Recycling (WRR) Grant Program Interlocal Agreement (and any necessary supplements) with King County to accept grant funds of up to \$362,954 to implement waste reduction and recycling education programs; establishing a project within the Operating Grants and Donations Fund; appropriating unanticipated and future revenues to that fund; and authorizing expenditures of said grant funds.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or his designee is authorized to execute a Washington State Department of Ecology Interlocal Agreement (and any necessary supplements) to accept grant funds of up to \$362,954 from the Coordinated Prevention Grant Program (CPG) to fund waste prevention and recycling projects, a copy of which Interlocal Agreement has been given Clerk's Receiving No.

46462.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend the same as authorized in said Interlocal Agreement.

Section 3. At the time of execution of said Interlocal Agreement and acceptance of said funds, a project shall be established within the Operating Grants and Donations Fund into which all said monies shall be deposited.

Section 4. The City Manager or his designee shall have responsibility for the administration of said grant monies and shall have all authority necessary to enter into agreements regarding the use thereof including consultant agreements to expend funds as provided in said grant agreement.

Section 5. The approximate amount and anticipated source of revenue for the grant proposal and acceptance is:

Section 6. Upon execution of said Interlocal Agreement the budget for the Operating Grants and Donations Fund shall be amended by appropriating revenues in the amount of the grant and acceptance herein authorized.



Operating Grants and Donations Fund	\$362,954

Provided, however, if the actual revenue received from the anticipated source specified in said Interlocal Agreement should be more or less than the anticipated amount set forth herein, the appropriation shall be adjusted to be equal to the amount actually received.

Section 7. This ordinance shall take effect and be in force five (5) days after passage and legal publication.


