

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 5855

AN ORDINANCE related to Residential Permit Parking repealing Ordinance Nos. 3581, 3881, and 4665 and creating a new Residential Permit Parking Zone 1 in the Surrey Downs neighborhood, restricting parking on streets within the zone to "No Parking 8 a.m. to 6 p.m. Except Saturday, Sunday, and Holiday, Except by Zone 1 Permit".

WHEREAS, Policy TR-119 of the Transportation Element of the Comprehensive Plan states that the City will minimize spillover parking from commercial areas, parks, and other facilities encroaching on residential neighborhoods through residential parking zones and other measures; and

WHEREAS, over the past 25 years the City has been working with residents living in the Surrey Downs Neighborhood to address spillover parking of vehicles from adjacent downtown businesses; and

WHEREAS, Council adopted Ordinance Nos. 3581, 3881, and 4665 to address the residential parking issues; and

WHEREAS, in order to conserve Police resources, Zone 1 restrictions will be changed; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Ordinance Nos. 3581, 3881, and 4665 are hereby repealed.

Section 2. A new Residential Permit Parking Zone 1 is hereby created on the following streets:

- 110th Avenue SE from Main Street to SE 3rd Street
- 109th Avenue SE from SE 1st Street to 113 feet south of SE 4th Street
- 110th Place SE from SE 2nd Street to SE 4th Street
- 111th Avenue SE from SE 1st Street to 154 feet south of SE 4th Street
- SE 2nd Street from 108th Avenue SE to 109th Avenue SE
- SE 2nd Street from 110th Avenue SE to 111th Avenue SE
- SE 1st Street from 109th Avenue SE to 110th Avenue SE
- SE 1st Street from 111th Avenue SE to 112th Avenue SE
- SE 3rd Street from 109th Avenue SE to 110th Avenue SE
- SE 4th Street from 109th Avenue SE to 112th Avenue SE


Section 3. Parking of vehicles on the street within Zone 1 is restricted to "No Parking 8 a.m. to 6 p.m. Except Saturday, Sunday, and Holiday, Except by Zone 1 Permit."

Section 4. The parking restrictions established by this ordinance shall be filed with and maintained by the City Clerk in accordance with Section 11.23.010 of the Bellevue City Code.

Section 5. This ordinance shall take effect and be in force thirty days after passage by the City Council.


