ORDINANCE NO. 5886

AN ORDINANCE related to Residential Permit Parking repealing Ordinance Nos. 4632, 4644, 4750, 4768, and 5281, and creating a new Residential Permit Parking Zone 9 in the West Bellevue neighborhood restricting parking on streets within the zone to "No Parking 8 AM to 9 PM Daily, Except by Zone 9 Permit".

WHEREAS, Policy TR-119 of the Transportation Element of the Comprehensive Plan states that the City will minimize spillover parking from commercial areas, parks, and other facilities encroaching on residential neighborhoods through residential parking zones: and

WHEREAS, over the past 15 years the City has been working with residents living in the West Bellevue Neighborhood to address spillover parking of vehicles from adjacent downtown businesses; and

WHEREAS, Council adopted Ordinance Nos. 4632, 4644, 4750, 4768, and 5281 to address the residential parking issue; and

WHEREAS, in order to ensure uniform enforcement of the zone restrictions and conserve Police resources, Zone 8 restrictions will be changed; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Ordinances Nos. 4632, 4644, 4750, 4768, and 5281 are hereby repealed.

Section 2. A new Residential Permit Parking Zone 9 is hereby created for the West Bellevue Neighborhood and will be signed on the following streets:

99<sup>th</sup> Avenue NE from NE 1<sup>st</sup> Street to NE 8<sup>th</sup> Street  
98<sup>th</sup> Avenue NE from NE 1<sup>st</sup> Street to NE 8<sup>th</sup> Street  
NE 5<sup>th</sup> Street from 96<sup>th</sup> Avenue NE to 99<sup>th</sup> Avenue NE  
NE 4<sup>th</sup> Street from 98<sup>th</sup> Avenue NE to 100<sup>th</sup> Avenue NE  
97<sup>th</sup> Avenue NE from NE 5<sup>th</sup> Street to end of cul-de-sac north of NE 5<sup>th</sup> Street  
NE 1<sup>st</sup> Street from 100<sup>th</sup> Avenue NE to end of cul-de-sac west of 98<sup>th</sup> Avenue NE  
The west side of 99<sup>th</sup> Avenue NE from Lake Washington Boulevard to NE 1<sup>st</sup> Street


Section 3. Parking of vehicles on the street within Zone 9 is restricted to "No Parking 8 AM to 9 PM Daily, Except by Zone 9 Permit."

Section 4. The parking restrictions established by this ordinance shall be filed with and maintained by the City Clerk in accordance with Section 11.23.010 of the Bellevue City Code.

Section 5. This ordinance shall take effect and be in force thirty days after passage by the City Council.
