ORDINANCE NO. 5934

AN ORDINANCE 1) authorizing execution of an amendment (and supplements if necessary) to the Interlocal Agreement providing the City with \$2,000,000 in King County Conservation Futures Levy proceeds, of which \$400,000 has already been budgeted in the 2009-2015 CIP Plan (CIP P-AD-15), and 2) amending the 2009-2010 General CIP Fund appropriation by \$1,600,000 from King County Conservation Futures Levy proceeds, and 3) amending the 2009-2015 Capital Investment Program (CIP) Plan to increase the budget for the Parks Levy Implementation Project (CIP Plan No. P-AD- 81) by \$800,000 & to increase the budget for the King County Special Property Tax Levy Project (CIP Plan No. P-AD-79) by \$800,000.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or his designee is authorized to execute an Amendment to the Interlocal Agreement (and supplements if necessary) providing the City with \$2,000,000 in King County Conservation Futures Levy proceeds, of which \$400,000 has already been budgeted in the 2009-2015 CIP Plan (CIP P-AD-15), a copy of which Amendment has been given Clerk's Receiving No. 46684.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend the same as authorized in said amended Interlocal Agreement.

Section 3. The City Manager or his designee shall have the responsibility for the administration of said monies and shall have all authority necessary to enter into agreements regarding the use thereof.

Section 4. The 2009-2010 General Capital Investment Program (CIP) Fund appropriation adopted by Ordinance No. 5851 on December 1, 2008, as previously amended, is hereby further amended to increase the appropriation to said CIP fund by \$1,600,000.

Section 5. The City's 2009-2015 General Capital Investment Program Plan adopted by Ordinance No. 5851 on December 1, 2008, as previously amended, is hereby further amended to increase the project budget for the Parks Levy Implementation Project (CIP Plan No. P-AD- 81) by \$800,000 & to increase the

budget for the King County Special Property Tax Levy Project (CIP Plan No. P-AD-79) by \$800,000.

Section 6. If the actual revenue received from the anticipated sources specified in said amended Interlocal Agreement shall be more or less than the anticipated amount set forth herein, the appropriations to the CIP Fund and Plan shall be adjusted to be equal to the amount actually received.

Section 7. This ordinance shall take effect and be in force five (5) days after passage and legal publication.


