

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 6026

AN ORDINANCE related to Residential Permit Parking repealing Resolution Nos. 4800 and 4928 and Ordinance Nos. 4777, 4813 and 4982, and creating a new expanded Residential Permit Parking Zone 2, restricting parking on the streets within the zone to "No Parking 7 a.m. to 4 p.m., Except Saturday, Sunday and Holiday and Except by Zone 2 Permit".

WHEREAS, Policy TR-119 of the Transportation Element of the Comprehensive Plan states that the City will minimize spillover parking from commercial areas, parks, and other facilities encroaching on residential neighborhoods through residential parking zones: and

WHEREAS, the City has been working with residents living near Interlake High School to address spillover parking of vehicles into adjacent neighborhoods; and

WHEREAS, Council adopted Resolution Nos. 4800 and 4928 and Ordinances Nos. 4777, 4813, and 4982, in order to address the residential parking issues in this area; and

WHEREAS, in order to ensure uniform enforcement of the zone restrictions and to conserve Police resources, Zone 2 restrictions need to be changed; and

WHEREAS, the existing ordinances and resolutions addressing residential parking issues in the Interlake High School area have been amended several times leading to some confusion; and

WHEREAS, to avoid confusion, it is in the best interest of the City to repeal the existing ordinances and resolutions and to adopt a new ordinance to address parking concerns; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Resolution Nos. 4800 and 4928 and Ordinance Nos. 4777, 4813 and 4982 are hereby repealed.

Section 2. A new Residential Permit Parking Zone 2 is hereby created for NE 21<sup>st</sup> Place between 164<sup>th</sup> Avenue NE and 165<sup>th</sup> Place NE, 162<sup>nd</sup> Avenue NE between NE 24<sup>th</sup> Street and NE 26<sup>th</sup> Street, 160<sup>th</sup> Avenue NE between Northup Way and NE 19<sup>th</sup> Place, NE 19<sup>th</sup> Place between 160<sup>th</sup> Avenue NE and 161<sup>st</sup> Avenue NE, and 161<sup>st</sup> Avenue NE between Northup Way and NE 19<sup>th</sup> Place.

Section 3. Parking of vehicles on the street within Zone 2 is restricted to "No Parking 7 a.m. to 4 p.m., Except Saturday, Sunday, and Holiday and Except by Zone 2 Permit. "

Section 4. The parking restrictions established by this ordinance shall be filed with and maintained by the City Clerk in accordance with Section 11.23.010 of the Bellevue City Code.

Section 5. This ordinance shall take effect and be in force thirty days after passage by the City Council.




