ORDINANCE NO. 6166

AN ORDINANCE authorizing execution of a one year grant agreement with the Washington State Department of Commerce to accept \$149,697.00 in grant funding for the Eastside Narcotics Task Force (ENTF); amending the 2013-2014 budget of the Operating, Grants, Donations and Special Reserves Fund in the amount of \$149,697.00; and authorizing expenditures of said grant funds.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or his designee is authorized to execute a one year grant agreement with the Washington State Department of Commerce to accept \$149,697.00 in grant funding for the Eastside Narcotics Task Force (ENTF), a copy of which grant agreement has been given Clerk's Receiving No. 51563.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend the same as authorized in said grant agreement.

Section 3. At the time of execution of said grant agreement and acceptance of said funds, a project shall be established within the Operating Grants, Donations, and Special Reserves Fund into which all said respective grant monies shall be deposited.

Section 4. The City Manager or his designee shall have responsibility for the administration of said grant monies and shall have all authority necessary to enter into agreements regarding the use thereof including purchase agreements to expend funds as provided in said grant agreement.

Section 5. The approximate amount and anticipated source of revenue for the grant proposal and acceptance are:

Section 6. Upon execution of said grant agreement, the budget for 2013-2014 Operating Grants, Donations, and Special Reserves Fund shall be amended by appropriating \$149,697.00 to said fund.

Provided, however, if the actual revenue received in 2014 from the anticipated sources specified in said grant award should be more or less than the anticipated

amount set forth herein, the appropriation for the 2013-2014 Operating Grants, Donations, and Special Reserves Fund shall be adjusted to be equal to the amount actually received.

Section 7. This ordinance shall take effect and be in force five (5) days after passage and legal publication.




