

CITY OF BELLEVUE, WASHINGTON

RESOLUTION NO. 7205

A RESOLUTION resolving to de-annex land to the City of Redmond from the City of Bellevue, pursuant to RCW 35.10.217 (2) et seq., a portion of Lot 232505-9061 located on the southern edge of the Microsoft campus and north of NE 28th Street.

WHEREAS, RCW 35.10.217 (2) authorizes the legislative body of a city or town on its own initiative by resolution to indicate its desire to be annexed to a city or town in whole or in part; and

WHEREAS, the Microsoft campus is an integrated site development located largely in Redmond and although this lot was annexed by Bellevue as a separate lot, it has now become an integrated part of the Microsoft campus; and

WHEREAS, Microsoft Corporation and the City of Redmond have indicated a desire to place all of the campus grounds within the corporate boundaries of Redmond; and

WHEREAS, indicating a desire to de-annex portions of this lot, nevertheless, the City of Bellevue in furtherance of Crossroads Subarea Policy S-CR-32 seeks to discourage the extension and connection of NE 28th Street to the Bellevue-Redmond Road and therefore excludes the southern 30 feet of Lot 232505-9061 from de-annexation under RCW 35.10.217(2); and

WHEREAS, Bellevue is accepting for consideration of this de-annexation action because, in furtherance of Comprehensive Plan Annexation Element Policy AN-9, the City recognizes the integrity of existing or future neighborhoods and the need for maintaining logical service areas as a general direction, when working with individual annexation requests; and

WHEREAS, the de-annexation and annexation is effective if the City of Redmond adopts a resolution concurring in the annexation;

WHEREAS, the City of Bellevue has complied with the requirements of the State Environmental Policy Act and the City Environmental Procedures Code; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES RESOLVE AS FOLLOWS:

ORIGINAL

Section 1. The City Council of the City of Bellevue resolves, pursuant to the provisions of RCW 35.10.217 (2), to indicate its desire to annex portions of Lot 232505-9061 to the City of Redmond from the City of Bellevue, and further as legally described hereto:

That portion of the Southeast quarter of the Northwest quarter of the Southeast quarter of Section 23, Township 25 North, Range 5 East, W.M., in King County, Washington, described as follows:

Beginning at the Southwest corner of said subdivision and a point on the Redmond city limits, as established by City of Redmond Ordinance No. 1764; thence Northerly along the West line of said subdivision and Redmond city limits 106.45 feet; thence Easterly along said Redmond city limits to a point on a line 30.00 feet Northwesterly and parallel with the centerline of Bellevue-Redmond Road, as measured at right angles to said centerline and lying 170.00 feet Northeasterly of the intersection of said parallel line with the South line of said subdivision; thence Southwesterly along said parallel line to the South line of said subdivision; thence Westerly along said South line to the Point of Beginning;

Except the South 30.00 feet thereof;

And Except that portion deeded to the City of Redmond by deed filed under Recording No. 8905250755.

Section 2. The Mayor of Bellevue directs the City Clerk to transmit a copy of this resolution to the clerk of the City of Redmond.
