RESOLUTION NO. 7729

A RESOLUTION authorizing the City Manager or his designee to 1) amend the 2007-2013 CIP Plan to amend the description of the 145<sup>th</sup> PI SE/SE 16<sup>th</sup> St to SE 24<sup>th</sup> St and SE 22<sup>nd</sup> St/145<sup>th</sup> PI SE to 156<sup>th</sup> Ave SE (CIP Plan No. PW-R-151) project to maintain the originally proposed improvements along 145<sup>th</sup> PI SE and along the north side of SE 22<sup>nd</sup> St from 145<sup>th</sup> PI SE to 156<sup>th</sup> Ave SE, but eliminate the installation of new curb, gutter and sidewalk where missing along the south side of SE 22<sup>nd</sup> from 145<sup>th</sup> PI SE to 156<sup>th</sup> Ave SE; and 2) execute a supplement to the consultant agreement with Skillings Connolly, Inc., in an amount not to exceed \$606,252, to prepare contract Plans, Specifications and Estimates for the project.


THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES RESOLVE AS FOLLOWS:

Section 1. The City Manager or his designee is hereby authorized to 1) amend the 2007-2013 CIP Plan to amend the description of the 145<sup>th</sup> PI SE/SE 16<sup>th</sup> St to SE 24<sup>th</sup> St and SE 22<sup>nd</sup> St/145<sup>th</sup> PI SE to 156<sup>th</sup> Ave SE (CIP Plan No. PW-R-151) project to maintain the originally proposed improvements along 145<sup>th</sup> PI SE and along the north side of SE 22<sup>nd</sup> St from 145<sup>th</sup> PI SE to 156<sup>th</sup> Ave SE, but eliminate the installation of new curb, gutter and sidewalk where missing along the south side of SE 22<sup>nd</sup> from 145<sup>th</sup> PI SE to 156<sup>th</sup> Ave SE; and 2) execute a supplement to the consultant agreement with Skillings Connolly, Inc., in an amount not to exceed \$606,252, to prepare contract Plans, Specifications and Estimates for the project, a copy of which supplement agreement has been given Clerk's Receiving No.


