

Setup and Pickup

- You are responsible for your own tables (tables also available for rent), display pieces, table coverings (floor length only) lights and cords.
- You may set up your display and merchandise on assigned date and time. Info packet will be sent after September 15, 2008.
- Okay to restock any time.
- Pick up and clean up Saturday, December 6, 5pm and not before.
- All items not claimed within two weeks following the show will be donated to a local charity.

Booth and Crafts

- Space is limited to 6'x3'. Exceptions apply.
- No "walk-around" booth. Exceptions apply.
- All display pieces must be clearly marked with your name and phone number.
- Two 60 watt clip lights recommended.
- One strand of twinkle lights recommended.
- All merchandise must be handcrafted by the exhibiting vendor.

Pictures

- New vendors submit or email three or more pictures of craft AND booth display with registration form and entry fee.

Vendor ID and Confirmation

- Upon acceptance into the show a confirmation packet will be sent after September 15, 2008 with your vendor number, setup date and time.
- If you do not have a vendor number, one will be issued to you in your confirmation packet.


Exhibitor Checks

- Checks will be mailed within fourteen business days following the show.
- Washington state sales tax will be claimed and reported by Hilltop Holiday Craft Show.

Liability Limitations

- Unless notified, show will take place regardless of inclement weather.

Registration and Fees

- \$45 nonrefundable registration fee payable to Hilltop Holiday must accompany attached registration form. \$55 after July 1, 2008.
- 6 ft. table available for rent for \$10 (add to registration fee).
- Registration form will not be accepted without 3 or more pictures of the product and pictures of booth.
- Registration fee does not guarantee specific floor space. We reserve the right to move and alter any and all display pieces and products at any time.

- This is a "central-checkout" show. Vendors DO NOT "sit and sell."
- Two hour volunteer work shift requested.
- Fees will be returned if merchandise is not approved, space is unavailable, or pictures do not show booth display.
- 22% commission on all sales and orders.
- \$25.00 will be deducted from vendor's paycheck for insufficient registration fee.
