**A RESOLUTION of the East Bellevue Community Council approving City Council Ordinance No. 6016 amending the Bellevue Land Use Code relating to the prohibition of helicopter landing facilities city-wide except for emergency purposes; specifically amending Land Use Code Sections 20.10.440 (Transportation and Utilities use chart and notes), 20.20.450 and 20.25D.070 (Bel-Red Transportation and Utilities use chart and notes) of the Bellevue Land Use Code; providing for severability and establishing an effective date.**

**WHEREAS**, on the 1st day of August 2011, the City Council of the City of Bellevue, Washington passed Ordinance No. 6016 amending the Bellevue Land Use Code relating to the prohibition of helicopter landing facilities city-wide except for emergency purposes; specifically amending Land Use Code Sections 20.10.440 (Transportation and Utilities use chart and notes), 20.20.450 and 20.25D.070 (Bel-Red Transportation and Utilities use chart and notes) of the Bellevue Land Use Code; providing for severability and establishing an effective date; and

**WHEREAS**, the subject matter of said Ordinance falls within the jurisdiction of the East Bellevue Community Council pursuant to RCW 35.14.040; and
