
NAME & DESCRIPTION OF PROPOSAL: Sanelli Tree Removal.
 Removal of 3 trees and replanting with native vegetation on a site with a critical area (West Tributary – Kelsey Creek). Trees have already been removed and the site has an active enforcement action 07-104164-EA.

The Environmental Coordinator of the City of Bellevue has determined that this proposal does not have a probable significant adverse impact upon the environment. 
