Instructions for Applicants:

Answer the questions briefly, with the most precise information known, or give the best description you can. You must answer each question accurately and carefully, to the best of your knowledge. In most cases, you should be able to answer the questions from your own observations or project plans without the need to hire experts. Giving complete answers to the questions now may avoid unnecessary delays later.
