1. Description of project is removal and replanting of vegetation on a steep slope critical area. Vegetation removal work has already been completed, this review is for remediation.
2. The property at 9427 SE Shoreland Dr. is approximately .45 acres at 19,434 square feet.
3. The proposed vegetation removal requires a clear and grade permit which has permit number 08-114712-GH. A permit to work in the right-of-way (not applied for yet) is also required as some of the vegetation to be removed is located within the right-of-way. Review of these permits is to allow remediation to occur.
4. The site has slopes over 40%.
5. Soil type is classified as Kitsap Silt Loam (KpD).
6. Removal of vegetation on this steep slope could allow erosion to occur. This steep slope will be replanted to prevent erosion.
7. The steep slope will be replanted to prevent erosion.
8. Other plants on site include deciduous trees and invasives (to be removed).
9. Invasive vegetation consisting of blackberry will be removed
10. The steep slope will be replanted.
11. A bald eagle nest is known to be within ½ mile of this site.
12. Work will consist of replanting which should not require machinery. Work shall be subject to BCC 9.18 for noise control.
13. The site is zoned R-3.5 and has a single-family residence located on it. There is a steep slope critical area located on the property.
