## DETERMINATION OF NON-SIGNIFICANCE

**PROPONENT:** David Rendle, City of Bellevue Transportation Department

**LOCATION OF PROPOSAL:** 4315 130<sup>th</sup> Place SE, Bellevue WA

### NAME & DESCRIPTION OF PROPOSAL:

Application to construct 412 linear feet of new curb, gutter and sidewalk. The sidewalk will be six feet wide and will be built on the east side of 130<sup>th</sup> Place SE from Newport Way to 4400 130<sup>th</sup> Place SE. The project includes construction of a rock wall and storm drainage improvements. The existing drainage ditch will be filled in and replaced with 12 " storm drainage pipe and catch basins. The proposed sidewalk and street work will create approximately 2,433 square feet of new impervious surface, and require 163 cubic yards of cut and fill.

The Environmental Coordinator of the City of Bellevue has determined that this proposal does not have a probable significant adverse impact upon the environment. An Environmental Impact Statement (EIS) is not required under RCW 43.21C.030(2)(C). **There will be an estimated 163 c.y. of material removed from the site to construct the rock wall and concrete curb, gutter, and sidewalk. Also minor storm drainage improvements.**

**There will be an estimated 67 c.y. of fill material used at the site for:**

- backfilling the ditch
- base material for the curb, gutter, and sidewalk.

**Fill material will be provided from a City of Bellevue approved source.**

**Yes, erosion could potentially occur during construction. Erosion BMP's will be employed and inspected during construction in accordance with City standards.**

**Approximately 2,433 s.f. of new impervious surface will be added in the Richards Creek Basin.**

**Erosion and sedimentation will be controlled through the implementation of Best Management Practices (BMP's) as described in the State Department of Ecology's Storm water Management Manual for the Puget Sound Basin, and according to City of Bellevue clearing and grading requirements, and will primarily include the installation of silt fences, catch basin inserts, and plastic covering. BMP's will be in place prior to beginning any clearing activity.**
