MEETING PURPOSE

The goal of the May 19 CAC meeting is to arrive at early draft alternatives to be presented to the public at open houses in June.

AGENDA TOPICS

Visual Preference Survey. Staff will summarize the responses to the recently-conducted online Visual Preference Survey. Some of the images identified as “very desirable” or “desirable” by survey respondents may be useful in helping to graphically convey land use concepts embedded in the alternatives.

Draft Alternatives. As stated above, the goal of the May 19 CAC meeting is to arrive at early draft alternatives to be presented to the public at open houses in June. The alternatives are intended to capture a range of ideas that can be explored further at public open houses, and that are flexible enough to respond to feedback received. This will allow the CAC to refine these alternatives into “final” draft alternatives at your June meeting, which will then be evaluated against the CAC evaluation criteria, Council principles, and environmental considerations over the summer.

Since the May 5 CAC meeting, staff and consultants have been working on revisions to the alternatives to respond to your input. These revised alternatives will be reviewed at the May 19 meeting. Because of the short interval between the May 5 and May 19 meetings, we were unable to include presentation materials in this packet. However, we will attempt to provide you with the revised alternatives prior to the May 19 meeting.

Next Steps. The next scheduled CAC meeting is June 2. Staff suggests that this meeting be rescheduled to later in the month. Possible meeting date(s) will be reviewed on May 19.

We look forward to the May 19 meeting.
