### NAME & DESCRIPTION OF PROPOSAL:


Land Use approval to install a watercraft lift to an existing 111 foot dock. A mini-mag lift is to be installed to an existing pier piling. The lift will be attached to the dock surface and braced at the bottom of the mast to the pile.

The Environmental Coordinator of the City of Bellevue has determined that this proposal does not have a probable significant adverse impact upon the environment.
