
The applicant is requesting a Clearing and Grading Permit with SEPA Threshold Determination for brush cutting of reed canary grass, purple loosestrife and Japanese knotweed from the banks of Kelsey Creek as it flows in ditches through the Lake Hills Greenbelt.

The Environmental Coordinator of the City of Bellevue has determined that this proposal does not have a probable significant adverse impact upon the environment. An Environmental Impact Statement (EIS) is not required under RCW 43.21C.030(2)(C). 



