
Land use approval to remove 4 hazardous cottonwood trees within the 50-foot Coal Creek critical area buffer. Mitigation includes the planting of 8 Douglas firs within the stream buffer.

The Environmental Coordinator of the City of Bellevue has determined that this proposal does not have a probable significant adverse impact upon the environment. An Environmental Impact Statement (EIS) is not required under RCW 43.21C.030(2)(C). This decision was made after the Bellevue Environmental Coordinator reviewed the completed environmental checklist and information filed with the Land Use Division of the Department of Planning & Community Development. This information is available to the public on request.
