

The following conditions are imposed under the Bellevue City Code or SEPA authority referenced:

1. NO CONSTRUCTION PROPOSED

This permit authorizes the location of seven (7) floating boatlifts within existing established moorage slips in the Newport Yacht Basin Marina. No construction is allowed. Boat lifts will be tied to the existing pier. No pier modification or repair is included with this scope of work. No building permit is required.

2. NOISE REQUIREMENTS

To mitigate noise impact to adjacent residents and the natural environment, construction shall utilize electric tools when feasible and attenuate pile driving sound through the use of a wooden dampening block and a vibratory pile driver. Hours of construction are limited to 7:00 a.m. to 6:00 p.m. on weekdays, and 9:00 a.m. to 6:00 p.m. on Saturdays which are not legal holidays.

3. OBTAIN ALL OTHER APPLICABLE STATE AND/OR FEDERAL PERMITS

Before work can be allowed to proceed, all required federal and state permits and approvals shall be received by the applicant prior to the commencement of any work. A copy of the approved Section 10 permit issued by the Army Corps of Engineer and the approved Hydraulic Project Approval (HPA) issued by the Washington State Department of Fish and Wildlife shall be submitted to the City of Bellevue, prior to construction, as required.

AUTHORITY: LUC 20.25E.080.B.1

REVIEWER: David Pyle

This permit is granted pursuant to the Shoreline Management Act of 1971 and nothing in this permit shall excuse the applicant from compliance with any other federal, state or local statutes, ordinances or regulations applicable to this project, but not inconsistent with the Shoreline Management Act (Chapter 90.58 RCW).

This permit may be rescinded pursuant to RCW 90.58.140(8) in the event the permittee fails to comply with the terms and conditions hereof.

Activity pursuant to this permit, or substantial progress toward activity, must be undertaken within two years of the date of final approval. This permit shall expire five years from the date of local approval.

Activity pursuant to this permit will not begin or is not authorized until twenty-one (21) days from the date of filing, as defined in RCW 90.58.140(6) and WAC 173-27-130, or until all review proceedings initiated within twenty-one (21) days from the date of such filing have terminated; except as provided in RCW 90.58.140(5) (A) (B) (C).




