APPENDIX I

Site

This site is located on the west leg of PSE's wood H-Frame transmission structure T23/6 #222195-167327, located near 13601 SE 10th Street in Bellevue, Washington. This is an existing Nextel wireless facility consisting of two (2) antennas, at one rad-center, flush mounted onto the west leg of the existing structure. Nextel's modification involves the replacement of the entire H-Frame structure with 2 new wood laminate poles and replacement of their 2 antennas with 2 new antennas flush mounted onto one leg of the new structure. Cingular also has wireless antenna located on the east leg of this same H-Frame structure (Kelsey Creek site #WA306-01). As part of this modification, Nextel will be responsible for the cost of replacing the entire H-Frame structure and transfer of Cingular's existing equipment on the existing pole to the new leg of the H-Frame, as well as the cost of installing their own facilities. However, Nextel is not responsible for the cost of the new wood laminate pole that Cingular will be located on.

Nextel's total finished antenna configuration will be two (2) antennas at one (1) rad-center on one leg of the H-Frame structure. Nextel's ground cabinets are located on private property. Nextel shall provide approved, detailed final construction drawings for PSE's review and approval.
