DETERMINATION OF NON-SIGNIFICANCE

PROPONENT: Honda of Bellevue Auto Shop
LOCATION OF PROPOSAL: 13541 SE 26th St

DESCRIPTION OF PROPOSAL: An application to operate an auto repair shop within an existing commercial building. No expansion of the building is proposed. Minor exterior improvements to the building are anticipated.

The Environmental Coordinator of the City of Bellevue has determined that this proposal does not have a probable significant adverse impact upon the environment. 
