Additional Fees and Charges

Water Main Shut-Off charge for work on Utility Extensions -- billed at \$118 per hour and \$140 per hour for overtime.
Direct or Regional Facility charges -- per ordinance or administrative rule
Latecomer Administrative Fee -- \$350

Effective 1/1/2010

- Costs in excess of the minimum fee will be billed to the applicant.
- ▲ We charge the hours of review and inspections against the deposit. If the deposit is used up, we bill additional hours monthly. We refund any remaining deposit balance. Fire Department Review is billed at \$124 per hour.
