SUBJECT: Downtown Transportation Plan Update

INTRODUCTION

The update to the Downtown Transportation Plan will address mobility issues and challenges and support Downtown growth forecasts looking out to 2030.

On February 9, 2012, staff will review the status of projects adopted in the Downtown Subarea Plan and the Pedestrian and Bicycle Transportation Plan. This project list is the starting place for developing the updated project list for the Downtown Transportation Plan Update. The status report update is for the Commission's information and no action is requested.

PROJECT LIST

The update of the Downtown Transportation Plan will build upon the projects that have been previously adopted and not yet constructed (See attached project list). Our role, to provide for multi-modal mobility in support of forecasted 2030 land use, is to recommend keeping, modifying or deleting existing projects, and to propose new projects that help achieve the updated mobility vision. Plan update principles will provide overall guidance and measures of effectiveness will evaluate project ideas relative to each other and to overall mobility goals.

Two separate project lists, adopted approximately 5 years apart, provide the starting point. These are the Downtown Subarea Plan (2004) transportation projects and the Pedestrian and Bicycle Transportation Plan (2009) projects. Both plans include projects specific to Downtown as well as projects that address mobility along corridors outside of Downtown that serve as neighborhood or regional connections.

There is overlap as well as divergence between the projects described in these two plans, and the level of detail is much different. For instance, both plans seek to improve pedestrian facilities. The Downtown Transportation Plan has one project (Project #601) that is an umbrella for the pedestrian system within the entire Downtown Subarea, while the Pedestrian and Bicycle Transportation Plan describes 13 sidewalk projects and 2 off-street pathways with Downtown. The "status" of Downtown Subarea Plan Project #601 will remain at "Partially Complete" for quite some time because there may always be improvements needed to Downtown pedestrian facilities. Individual Pedestrian and Bicycle Transportation Plan projects may be more easily removed from the list as they are completed.

- **Project status**

Project status is described in the attached table as being Complete, Partially Complete, or Not Complete. A complete project is one that has been constructed with a design similar to that described in the Plan. A Partially Complete project is one that has a completed segment of a longer project, or one that is complete but with some design components omitted from the original project description. Not complete projects – well, those are not complete. Some of these projects have been excluded from the travel demand modeling baseline project list for the Downtown Transportation Plan Update because they have been deemed to be “not reasonably foreseeable” within the 2030 time frame of this plan update. Where a project is included in the 2009-2020 Transportation Facilities Plan (TFP), the TFP project number is noted in the “Status” column.

PROJECT IMPLEMENTATION

Projects within Bellevue’s control are completed generally by public investments through the Capital Investments Program (CIP) and by private sector infrastructure improvements completed as conditions of development approval, or perhaps a combination of both. Grant funds are frequently used to supplement other resources to fill project funding gaps.

Other projects such as improvements to the regional freeway system and transit system improvements are achieved through advocacy with the City’s state and regional mobility partners such as the Washington State Department of Transportation, King County Metro and Sound Transit. The City’s advocacy role helps to create political support for projects and to help aggregate the resources needed to fund these regional mobility projects.
