SUBJECT: 2014-2019 Transportation Improvement Program

## Purpose

At the April 11 Commission meeting, staff will present an overview of the status of projects in the current 2013-2018 Transportation Improvement Program (TIP) and proposed updates for the new 2014-2019 TIP. We will also review the function of the TIP in the transportation planning and financial programming process. Staff seeks Commission input on the updates and your direction to return with a Proposed 2014-2019 TIP to a public hearing, tentatively scheduled for May 9, 2013.

## Background


State law (RCW 35.77.010) requires all local jurisdictions to annually adopt a six-year program of transportation improvements, known as the Local TIP, by the end of June each year. On April 12, 2012, the Transportation Commission hosted a public hearing and recommended adoption of the current 2013-2018 Local TIP. On May 21, 2012, the City Council adopted the current TIP (Resolution No. 8396).

The six-year Local TIP serves as a rough work plan for the development of local transportation systems and, as such, represents an important planning component under the State's Growth Management Act. The Washington State Department of Transportation (WSDOT) and Puget Sound Regional Council (PSRC) use Local TIPs as a tool for coordinating the transportation programs of local jurisdictions with those of regional agencies. PSRC also monitors Local TIPs for projects of regional significance (to be modeled for Air Quality conformity) and projects supported by federal funds. These projects are incorporated into the Regional TIP, which is then forwarded for inclusion in the State TIP.

For the City of Bellevue, the primary importance of the Local TIP is that, in most instances, projects must be included on a Local TIP to be eligible for state and federal grant programs. Because Local TIPs are not revenue constrained, like Bellevue's Capital Investment Program (CIP) plan and Transportation Facilities Plan (TFP), the City can include projects we would choose to implement within the 6-year timeframe, if the funding were available. Local TIPs then, by definition, represent a more comprehensive listing of projects deemed necessary to ensure the safe and efficient operation of the City's transportation system.

Figure 1 illustrates the relationship between the TIP, the Capital Investment Program, and the Transportation Facilities Plan.

**Proposed City of Bellevue 2014-2019 TIP**

Attached to this memo is the current 2013-2018 TIP project list, with mark-ups showing proposed revisions for the 2014-2019 TIP update. All projects listed fall within one of four color-coded categories, or sections, as described below:

- Section I** Uncompleted CIP Projects (included in the Adopted 2013-2019 Capital Investment Program Plan – full or partial funding secured)
- Section II** TFP Projects (unfunded projects included in the Proposed 2013-2024 Transportation Facilities Plan)
- Section III** Other unfunded local projects identified or scoped by completed Alternative Analyses and Planning or Pre-design Studies (may be considered for inclusion in the next TFP Update)
- Section IV** Regional or Outside Agency-led projects in which the City may choose to participate financially

Projects proposed to be added to, deleted from, or transferred between sections of the current 2013-2018 TIP can be identified by the following three colors on the attachment:

New

New projects proposed to be added to the current 2014-2019 TIP are shaded green.

There are 14 new projects proposed to be added to the TIP as follows:

- Ten projects are newly funded 2013-2019 CIP plan projects. These projects would be added to Section I of the TIP;
- Three projects are on the proposed 2013-2024 TFP update list and would be added to Section II of the TIP; and
- One new project is proposed to be added to Section III for the Downtown Sub-surface Arterial project.

Remove

Projects included in the current 2013-2018 TIP that are proposed to be removed due to their completion, deletion, or combination with another existing TIP project are shaded red.

There are 41 projects proposed to be removed from the current 2013-2018 TIP:

- One CIP project in Section I is projected to be completed in 2013;
- One CIP project in Section I is was deleted from the 2013-2019 CIP plan;
- 27 TFP projects in Section II were removed because they are not recommended in the 2013-2024 TFP update;
- One Section III project was combined with an existing 2013-2019 CIP plan project in Section I;
- One Section III project was superseded by a new 2013-2019 CIP plan project in Section I;
- Seven Section III projects are proposed to be removed from the TIP as implementation is not expected during the 2014-2019 timeframe; and
- Three Section IV projects are being combined with other projects within that section.

Transfer

Projects included in the current 2013-2018 TIP that are proposed to be transferred between TIP sections have been shaded light blue.

There are 20 projects proposed to be transferred between TIP sections:

- One 2011-2017 CIP project funded for pre-design work is proposed to be transferred into Section II as funding was not continued in the 2013-2019 CIP Plan;
- Seven projects from the TFP section (Section II) are proposed to be transferred into Section I as they are now included in the 2013-2019 CIP plan;
- One TFP project is proposed to be transferred into Section III as it was not recommended for the 2013-2024 TFP Update;
- Three Section III projects are proposed to be transferred into Section I as they are now part of the 2013-2019 CIP plan;
- Eight Section III projects are proposed to be transferred into Section II as they are proposed projects for the 2013-2024 TFP update.

The project costs listed in the “Project Funding Categories” columns of the attachment represent, in most cases, the actual level of funding budgeted or estimated to be needed by the City during the six-year timeframe of the Local TIP. Because the Local TIP is not revenue constrained, project costs are given one of two designations:

1. Secured Funding. Projects with secured funding have local or other sources of funding allocated to support full or partial project implementation.
2. Unsecured Funding. This designation reflects the portion of project costs that have no dedicated source of funding. Projects with unsecured funding at any level are included on the list for planning purposes should funding become available within the six-year timeframe.

## **Next Steps**

Proposed TIP update timeline:

- April 11, 2013 – Commission status review of 2013-2018 TIP and potential updates for the 2014-2019 TIP.
- May 9, 2013 -
  - Commission hosts a Public Hearing on the content of the Proposed 2014-2019 TIP.
  - Commission considers public testimony, potentially amends the Proposed 2014-2019 TIP, and recommends a TIP for City Council consideration.
- June, 2013 – City Council reviews and adopts the Proposed 2014-2019 TIP.
- June, 2013 – Formatting and submittal of the adopted 2014-2019 TIP to PSRC and WSDOT.




