CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 4470

AN ORDINANCE authorizing and directing acceptance and execution of a grant agreement with the State of Washington Department of Transportation for the 140th Avenue S.E. (Sammamish High School) project, amending the budget for the Transportation Grant Trust Fund by appropriating funds received in excess of estimated revenues to the fund; and authorizing expenditure of said grant funds.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The City Manager or his designated representative is hereby authorized and directed to accept and execute a Department of Transportation grant agreement with the State of Washington for the 140th Avenue S.E. (Sammamish High School) transportation project; a copy of which grant agreement has been given Clerk's Receiving No. 18705.

Section 2. The appropriate administrative officials of the City are hereby authorized to receive monies and to expend the same as authorized in said grant agreement authorized pursuant to Section 1 of this ordinance.

Section 3. All of said monies shall be deposited in the Transportation Grant Trust Fund.

Section 4. The City Manager or his designated representative shall have responsibility for the administration of said grant.

Section 5. The approximate amount and anticipated source of revenue for the grant herein accepted is as follows:

State of Washington Department of Transportation \$103,500.00

Section 6. Upon execution and acceptance of said grant funds, the budget for the Transportation Grant Trust Fund is hereby amended by appropriating to that fund anticipated revenues in excess of estimated revenue in the amount of the grant and acceptance herein authorized to the Transportation Grant Trust Fund, currently anticipated in the following amount:


Provided, however, if the actual revenues received from the anticipated source specified in said grant agreement should be more or less than the anticipated amount set forth herein, the appropriation shall be adjusted to be equal to the amount actually received.

Section 7. The City Clerk is directed to transmit a certified copy of this ordinance to the Auditor of the State of Washington, Division of Municipal Corporations.

Section 8. This ordinance shall take effect and be in force five (5) days after passage and legal publication.


