

The Bellevue Police Department is releasing the following information. In [Chapter 125, Laws of 2006](#), the Legislature made it a Class C Felony for certain sex offenders to remain or reenter into certain places. The law makes it illegal for some sex offenders, called “covered offenders,” to remain or reenter places, called “covered entities.”

- A “covered offender” has a prior conviction indicating a risk to children and a risk to reoffend and have convictions for certain crimes indicating a risk to children.
- A “covered entity” is a place whose primary purpose is to provide for the education, care, or recreation of a child or children.

Covered entities may ask covered offenders to leave their property. They may give the covered offender a trespass notice. If, after notice, the covered offender refuses to leave or reenters, the offender may be charged with Trespass by a Sex Offender.

The individuals below are Covered Offenders as defined in Chapter 125, L 2006 who are registered as residing within the City of Bellevue. **THEY ARE NOT WANTED BY THE POLICE AT THIS TIME.** This notification is not intended to increase fear. Misuse of this information will jeopardize the ability of law enforcement to provide this information in the future.
